

HATFIELD PEVEREL BURIAL GROUND

THE FEES, PAYMENTS AND SUMS SET OUT BELOW ARE EFFECTIVE FROM 1st MARCH 2023

A resident is a person who was resident in the Parish at the time of their death.

Non-resident is a person not living in the Parish at the time of death with the following exceptions:

- i) Former residents who purchased a grant of exclusive right of burial whilst resident in the Parish.
- ii) Former residents who (within the last 5 years) by reason of age and infirmity are forced to move out of the Parish for purposes of care.
- iii) In the case of a still born child or child whose age at the time of death did not exceed the age of 12, where the parents (or one of them) at the time of death were residents.

PART 1 – INTERMENT FEES

***THE FEES INDICATED BELOW DO NOT INCLUDE
THE DIGGING OF THE GRAVE***

	Resident	Non-Resident
Stillborn child born after 24 weeks' gestation	£15	£25
Child under 18 years	£155	£780
Over 18 years (burial)	£235	£780
Over 18 years (cremated remains)	£175	£560

The charge for digging a cremated remains plot is £60. The digging of a burial plot must be arranged by the funeral director, with all spoil removed from the site.

PART 2 - EXCLUSIVE RIGHTS OF BURIAL IN EARTHEN GRAVES

For the exclusive right of burial for 99 years in an earthen grave.

	Resident	Non-Resident
Stillborn child born after 24 weeks' gestation	£25	£125
Child under 18 years	£250	£1,000
Over 18 years (burial)	£520	£1,250
Over 18 years (cremated remains)	£330	£625

If a plot has been reserved and then the owner at a later stage decides they no longer wish to be interred in Hatfield Peverel Burial Ground, reimbursement of the original purchase fee will be given less an Administration Fee of £50.

The fees indicated for the various heads of Part 2 include the Deed of Grant and all the expenses thereof.

PART 3 - MONUMENTS, GRAVESTONES, TABLETS AND MONUMENTAL INSCRIPTIONS

For the right to erect or place on a grave in respect of which the exclusive right of burial has been granted.

Full memorial not exceeding 7' x 3'	£190	£190
Full memorial not exceeding 7' x 6'6"	£375	£375
Headstone or footstone not exceeding 3'	£125	£125
Kerb stones or border stones enclosing a space not exceeding 7' x 3'	£125	£125
Kerb stones or border stones enclosing a space not exceeding 7' x 6'6"	£220	£220
Vase not exceeding 12"	£60	£60
Tablet on any grave not exceeding 2' x 2'	£100	£100
Additional inscription on existing headstone	£40	£40

PLEASE NOTE: IT IS RECOMMENDED THAT AT LEAST SIX MONTHS IS ALLOWED FROM THE DATE OF AN INTERMENT TO THE ERECTION / RE-ERECTION OF A MEMORIAL ON A GRAVE TO ALLOW THE EARTH TO SETTLE SUFFICIENTLY

Scattering of Ashes

The fees for the scattering of ashes plot are as follows:

	Resident	Non-Resident
To allow the scattering of ashes and permission to hang a plaque (6" x 3" in brushed brass effect laminate) on the fence	£90	£180

The fee to scatter more than one lot of ashes at the same time would be £90/£180 with allowance for only one plaque to be hung.
