**19/47 Apologies for Absence**

Apologies were received and accepted from Cllrs Elliston, Dervish and Renow.

**19/48 Declarations of Interest**

No declarations of interest were made.

**19/49 Public Participation**

Mr Pandya apologised for those putting up with the recycling bins. He made it clear that it was his oversight and not the Parish Council's.

Three members of the public raised the following:

- Disappointing that no consultation was carried out before moving the bins.
- Considerations of the noise – from 6.30am until 9.30pm.
- Area gets abused – things get dumped.
- Concerns of potential for rats.
- Residential area is not a usual location for recycling bins.
- Why were the bins moved? Cllr Weale confirmed that Braintree District Council were retaining ownership of the area behind the shops and so the bins were moved so that they remain on their land.
- Disabled parking bays – Mr Pandya confirmed that Parish Council discussions resulted in the disabled bays being put closer to the surgery.
- Tenants above shops – can the loading bays be used for resident parking? Mr Pandya felt this would be a useful solution. The Braintree District Council Asset Management Team are responsible for this issue and will make the decision.
- Studs are now where the flat numbers used to be. Mr Pandya confirmed that the studs separate the Braintree District Council and Parish Council owned areas.
- £500 per parking permit per year was felt too high. The Parish Council confirmed that it will increase to £600 per permit.

**19/50 Recycling bins at Hadfelda Square Car Park**

Following a robust discussion between Councillors and Mr Pandya, two motions were formulated and voted on.

**MOTION 1** the Parish Council to agree to the permanent removal of recycling bins by Braintree District Council. Motion **NOT PASSED**.

**MOTION 2. IT WAS RESOLVED THAT** the Parish Council to agree to Braintree District Council moving the recycling bins to the previous location for a period of three months. Following this time, if a permanent location is not found, Braintree District Council will be asked to remove them permanently.

**19/51 IT WAS RESOLVED THAT** the Parish Council to pay an additional sum of £312 inc VAT to Mobile Thrones to hire additional toilet facilities for Party in the Park.
