

HATFIELD PEVEREL BURIAL GROUND

***THE FEES, PAYMENTS AND SUMS SET OUT BELOW ARE EFFECTIVE FROM
1 JUNE 2019***

A resident is a person who was resident in the Parish at the time of their death.

Non-resident is a person not living in the Parish at the time of death with the following exceptions:

- i) Former residents who purchased a grant of exclusive right of burial whilst resident in the Parish.
- ii) Former residents who (within the last 5 years) by reason of age and infirmity are forced to move out of the Parish for purposes of care.
- iii) In the case of a still born child or child whose age at the time of death did not exceed the age of 12, where the parents (or one of them) at the time of death were residents.

PART 1 - INTERMENTS

***THE FEES INDICATED BELOW DO NOT INCLUDE
THE DIGGING OF THE GRAVE***

	Resident	Non-Resident
i. For any interment of the body of a still-born child or of a child whose age at the time of death did not exceed one month	£10.00	£20.00
ii. For any interment of the body of a child whose age the time of death exceeded one month, but did not exceed twelve years	£125.00	£625.00
iii. For any interment of the body of a person whose age at the time of death exceeded twelve years	£190.00	£625.00
iv. For the interment of cremated remains in a grave in respect of which an exclusive right of burial has been granted	£140.00	£450.00

PART 2 - EXCLUSIVE RIGHTS OF BURIAL IN EARTHEN GRAVES

For the exclusive right of burial for 99 years in an earthen grave up to 9 feet by 4 feet

i)	For the interment of the body of a still-born child or of a child whose age at the time of death did not exceed one month	£ 20.00	£100.00
ii)	For any interment of the body of a child whose age the time of death exceeded one month, but did not exceed twelve years	£200.00	£ 800.00
iii)	For any interment of the body of a person whose age at the time of death exceeded twelve years	£415.00	£1000.00
iv)	For the exclusive right of burial of cremated remains in an earthen grave 24 inches by 24 inches	£265.00	£500.00

If a plot has been reserved and then the owner at a later stage decide they no longer wish to be interred in Hatfield Peverel Burial Ground, a reimbursement of the original purchase fee will be given less an Administration Fee of £50.00.

The fees indicated for the various heads of Part 2 include the Deed of Grant and all the expenses thereof.

PART 3 - MONUMENTS, GRAVESTONES, TABLETS AND MONUMENTAL INSCRIPTIONS

For the right to erect or place on a grave in respect of which the exclusive right of burial has been granted -

i.	Full Memorial not exceeding 7 ft by 3 ft	£150.00	£150.00
ii.	Full Memorial not exceeding 7 ft by 6 ft 6"	£300.00	£300.00
iii.	Headstone or Footstone not over 3 ft	£100.00	£100.00
iv.	Kerb Stones or Border Stones enclosing a space not exceeding 7 ft by 3 ft	£100.00	£100.00
v.	Vase, not exceeding 12 inches	£50.00	£50.00
vi.	Tablet on any grave not exceeding 2 ft by 2 ft	£80.00	£80.00

THE FEES INDICATED IN PART 3 INCLUDE THE FIRST INSCRIPTION. FOR EACH INSCRIPTION AFTER THE FIRST, A FEE OF £40.00 IS PAYABLE

PLEASE NOTE: IT IS RECOMMENDED THAT AT LEAST SIX MONTHS IS ALLOWED FROM THE DATE OF AN INTERMENT TO THE ERECTION / RE-ERECTION OF A MEMORIAL ON A GRAVE TO ALLOW THE EARTH TO SETTLE SUFFICIENTLY.

Scattering of Ashes

The fees for the scattering of ashes plot are as follows:

To allow the scattering of ashes and permission to hang a plaque (6" x 3" in brushed brass effect laminate) on the fence.	£75.00	£150.00

The fee to scatter more than one lot of ashes at the same time would be £75.00 with allowance for only one plaque to be hung.
